- 1. Due to the risk of infection with the SARS-CoV-2 virus (COVID-19) in Poland, as well as guidelines issued by the Ministry of Culture and National Heritage, persons wishing to participate in the Walks around the City, which will take place from 3 to 11 July this year, within the framework of the Gdynia Design Days 2021 Festival, organised by the Pomeranian Science and Technology Park Gdynia (PPNT Gdynia | Design Centre Gdynia), and the Design Centre Gdynia (PPNT Gdynia | Design Centre Gdynia), and the Design Centre Gdynia (PPNT Gdynia | Design Centre Gdynia). The persons wishing to participate in "City Walks" held between 3-11 July this year as part of the Gdynia Design Days 2021 Festival organised by the Pomeranian Science and Technology Park Gdynia) | Design Centre are obliged to provide personal data and make the following statement in order to increase the safety of persons participating in the event, as well as to establish contact in the event that any of the participants is infected with the SARS-CoV-2 virus.
- 2. I, the undersigned, give my details and/or minor and declare that:

1) I do not observe in myself, any symptoms characteristic of influenza or SARS-CoV-2 virus (COVID-19), in particular: elevated temperature, fever, cough, shortness of breath, respiratory problems, loss of smell or taste, or other disturbing symptoms, and I am not in quarantine or under epidemiological surveillance.

2) I have not been out of the country within the last two weeks.

3) Within the past two weeks, I have not knowingly been in contact with infected persons, in quarantine, returning from a COVID-19 infected country/region.

4) If I become aware that I am infected with COVID-19 or experience symptoms typical of this virus, or suspect that I may be a carrier of the virus or become aware that I have had contact with an infected person or person in quarantine, I will not participate in the events taking place as part of the Gdynia Design Days 2021 Festival organized by PPNT Gdynia | Design Centre.

5) I have acquainted myself with the rules of participation in the events "Walks" which can be found in the Rules and Regulations of Participation in Events organised as part of Gdynia Design Days 2021 published at www.gdyniadesigndays.eu organised by PPNT Gdynia Design Centre and I undertake to abide by them.

6) I am fully aware that despite adequate safety measures taken by PPNT Gdynia |Design Centre, participation in the event carries a risk of COVID-19 infection, and therefore I declare that I understand this risk and voluntarily participate in the events and/or consent to the participation in the events of persons under my care. In the event that I am infected with COVID-19, I will not make any claims against PPNT Gdynia | Design Centre.

7) I undertake to immediately inform the local sanitary and epidemiological services and PPNT Gdynia | Centrum Designu (e-mail: k.klimek.@ppnt.pl) about any changes in my health situation in relation to the COVID-19 virus and persons under my care participating in the event, occurring within two weeks of the event.

8) This declaration made by me also applies in full to any minor in my care who is attending the event.

3. In connection with the provisions of Article 13 and Article 14 of REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter RODO) (OJ EU. 2016, L 119, item 1);

1) I acknowledge that my personal data/personal data of the underage participant whom I represent included in the declaration will be placed in a personal data file - in order to transfer them at the request of competent sanitary services to the extent necessary for epidemiological investigation in case of infection;

2) I declare that I give my consent/do not give my consent\* to the free of charge use, exploitation and dissemination of my image/ of the underage participant whom I represent by PPPNT Gdynia as the Administrator of the personal data for the purposes of carrying out statutory, informational and promotional activities of PPNT Gdynia.

By giving my consent I acknowledge that during events organized or co-organized by PPNT Gdynia | Design Centre, due to the nature of the events and their scale, there is a possibility that photographs or films may be taken and then published and processed, which may capture the image of the persons present. I am also aware that my image, as well as the image of the underage participant whom I represent, may be used for various forms of processing, framing and composition (i.e. recording, photographing, filming or otherwise recording my image and transmitting, distributing or displaying that image, as well as creating online audio publications, podcasts/videos or video conferences/promotional materials, i.e. This consent covers all forms of public presentations, fairs, exhibitions and other events related to the realization of statutory tasks by PPNT Gdynia.) underage participant whom I represent may be juxtaposed with images of other people, may be accompanied by an accompanying comment. My image and the image of the minor participant whom I represent may not be used in any form or publication offensive to me or otherwise violate my personal rights / the personal rights of the minor participant whom I represent. This consent is free of charge and is not limited in terms of quantity, time or territory.

Note: Persons who do not agree to the processing of their image or wish to withdraw their consent are asked to notify the Organiser directly before the commencement of the event/workshop etc. Further participation in a given event/workshop etc. without the above notification shall be treated by the Administrator as an explicit action confirming consent to the processing of your image or the image of the underage participant you represent.

3) Your personal data will be processed in order to:

- to carry out obligations incumbent on the Administrator (Article 6(1)(b), (c), (e) of the DPA);
- asserting/defending claims, clarifying disputes (Article 6(1)(b), (c) of the DPA);
- sending of the Newsletter and processing of your image if you have given your consent (Article 6(1)(a) RODO);
- in order to ensure epidemic safety in accordance with the applicable guidelines (Article 6(1)(c) RODO);

4) Your personal data will be processed in principle:

- for the period of use of your account;
- for the time of implementation of promotional, advertising or statutory activities of the Administrator;
- after the completion of the aforementioned activities, the data will be stored for the purposes of fulfilling obligations stipulated by law (including archiving, claiming or defending one's rights);

 until an objection is made or consent is withdrawn; after the withdrawal of consent or objection, personal data may be stored for the purpose of proving the correctness of fulfillment of legal obligations incumbent upon the Administrator and the related claims (the time limits for claims are calculated from the withdrawal of consent or objection).

5) The recipients of your personal data will be authorised persons, public authorities, entities/institutions defined by law or persons, entities cooperating with the Administrator on the basis of concluded contracts and agreements in the performance of activities related to the Administrator's statutory activity (including entities processing entrusted data and entities providing electronic or payment card services) or public entities entitled to receive data on the basis of valid legal provisions, including the Chief Sanitary Inspector and the epidemic safety services.

6) Providing your personal data is voluntary, however, if you do not do it, it will not be possible to achieve the purposes for which the data were collected, e.g. setting up an account / event registration / Newsletter / image processing.

7) Your personal data will not be transferred outside the European Economic Area or to an international organization.

8) The Administrator does not make decisions by automated means, including in the form of profiling within the meaning of Article 22(1) and (4) of the RODO.

9) Under the terms of the data protection legislation, you have the right to access your data, rectification, erasure and deletion of your account, restriction of processing, data portability, withdrawal of consent (without affecting processing before the date of withdrawal) and to object to processing. The right to object to data processing does not apply if: the processing of personal data is based on consent, the processing of data is necessary for the performance of a contract to which you are a party, the processing is necessary for the fulfillment of a legal obligation by the Administrator. In addition, you have the right to lodge a complaint to the supervisory authority - the President of the Office for Personal Data Protection.
